Family OCG Guilty of 1 Tonne Cocaine Conspiracy

28 April 2025

Charlotte Hole and Sam Willis prosecuted a family of drug traffickers responsible for moving at least one tonne of cocaine from ports in the South East to towns and cities across the UK.

Headed up by grandmother Deborah Mason, self-described as 'Gangster Debbs' and saved in another defendant's phone as 'Queen Bee', the close-knit group of nine defendants were responsible for collecting up to 60 1kg blocks of cocaine at a time from the Harwich / Colchester area, and then delivering them to serious organised crime groups in Rotherham, Bradford, Leicester, Birmingham, Bristol and Cardiff for onward supply. Around 55 individual trips were made by the group during 2023, each trip involving multiple drug drops or cash collections, amounting to around a tonne of cocaine in total.

The trial of eight of the defendants at Woolwich Crown Court concluded this week, and involved the presentation of cell site and ANPR mapping, surveillance evidence, and a schedule of 7,500 messages exchanged between the defendants revealing the inner workings of the conspiracy.

Two of the defendants pleaded guilty during the trial and six were convicted by the jury. One defendant had already pleaded guilty at an earlier stage in the proceedings.

Charlotte and Sam were instructed by Rob Hutchinson of the CPS Complex Casework Unit.

### OCG who Acquired a Gun to Protect their Class A Drug Dealing Business Convicted

19 February 2024

Charlotte Hole, leading Anna Dutka, secured convictions against all 5 defendants in this conspiracy to supply Class A drugs. The defendants were members of an Organised Crime Group running a drug line which supplied heroin and crack cocaine across Tower Hamlets, and had agreed to possess a firearm and ammunition to protect their drug dealing business.

### Containers filled with 270kg of cocaine, 2,500kg of cannabis and 18.6m cigarettes

15 December 2023

Charlotte Hole and Sam Willis prosecuted two importers for bringing into the UK 270 kilograms of cocaine, 2.5 tonnes of cannabis and 18.6 million duty-free cigarettes, all hidden inside shipping containers. Valued at £24m, the drugs had been vacuum-packed and then secreted inside crates of animal feed, yams and oranges. The cigarettes were concealed in a similar manner, hidden inside crates of snack food, coconut fibre and biscuits - the tax that should have been paid on them if imported lawfully totalled just over £9m.

The case followed an extensive investigation by the South West Regional Organised Crime Unit, who became involved when a farmer discovered 189kg of cocaine in a shipping container full of animal feed. The defendants had unsuccessfully tried to divert the container to their warehouse in London so that the drugs could be removed

before the container reached the farm.

During the 16-week trial, the conspiracy was evidenced using material from numerous encrypted communications services. The jury heard technical evidence involving cell site analysis, VPN services, and IP address resolution.

### OCG prosecuted for spree of commercial burglaries

22 June 2023

Following an eight-week trial at Croydon Crown Court, eight members of an organised crime group have been sentenced for their involvement in a spree of commercial burglaries across London. Prosecuted by Charlotte Hole and Sam Willis, the group targeted bookmakers and other shops, typically breaking in during the night using sledgehammers. In total they carried out 12 burglaries of commercial premises, and a robbery at a cash and carry, over a period of 4 years. They stole tens of thousands of pounds in cash, and caused hundreds of thousands of pounds worth of damage to buildings, security systems, and businesses. The robbery involved a staff member of the cash and carry being assaulted and then bound hand and foot with cable ties whilst others sought to enter the building.

Ladders and tools were used to scale walls and breach roofs or walls of premises to gain access to the area where a safe was located. They then either removed or broke into the safe to steal cash, using hand tools and angle grinders. CCTV cameras were destroyed or blacked out, or the hard drives removed altogether as forensic countermeasures, and alarm systems were destroyed or the cables and power supply were cut, in an attempt to avoid detection.

Investigated by the Flying Squad, the evidence against the eight defendants included CCTV, covert surveillance, forensics, mobile telephone downloads, and cell site mapping.

### Op Varbody [Snaresbrook] 2025

Family OCG trafficking 1 tonne of cocaine around the UK

#### Romance Fraud

### R v S, B, P, Q, R [Snaresbrook] 2022

Conspiracy to Supply Class A Drugs

Leading Dominic Hockley, 2HB – prosecution of an organised crime group identified through Operation Venetic, involving Encrochat and SkyECC material. The group had conspired to supply wholesale quantities of Class A drugs, and weapons including a Skorpion machine pistol and handguns.

## R v BS [Basildon] 2022

Attempted Murder

Instructed as junior alone to prosecute a 15 year old for the attempted murder by stabbing of another teenage boy.

# R v AA [CCC] 2021

Attempted Murder

Led by Rupert Kent, prosecuting a father charged with attempting to murder his young daughter by stabbing. Trial was before by a High Court judge, and issues relating to mental health, capacity, and the admissibility of confessions to medical professionals arose.

## R v D, H, H, M, D, L-F [Guildford Crown Court] 2021

Conspiracy to Convey Drugs into Prison

Instructed as junior alone to prosecute a multihanded conspiracy to convey drugs into prison, involving admissibility of intercepted telephone calls.

### R v CU & others [Kingston] 2020

Commercial Burglary

Prosecution of twelve defendants in relation to a string of high value commercial burglaries involving the theft of rare and precious books. Led by Catherine Farrelly.

## R v CU & Ors [Kingston] 2020

The Feltham Book Heist

Leading Charlotte Hole. The prosecution of 12 defendants for a number of high-value commercial burglaries, including the theft of rare books by Isaac Newton & Francisco Goya. The prosecution arose out of a JIT (Joint Investigation Team) with Romanian and Italian law enforcement and concerned legal issues in relation to the admissibility of extraterritorial evidence and the presentation of a significant amount of telephone and cell-site evidence. The case attracted considerable interest in the national and international press.

### R v PS & MO [Woolwich] 2020

Confiscation following conviction for conspiracy to supply drugs

£384k confiscated from drug dealers following convictions for conspiracy to supply drugs with a street value of over £10m, after 951kg of cannabis was found in a lorry load of rabbit hay. Junior alone. (R v Seabrook & ors [Woolwich] 2018)

### R v LV [Guildford] 2019

Armed Robbery

Prosecution of an armed robbery of a Post Office by a defendant armed with a handgun. Junior alone.

#### R v H [Maidstone] 2019

Assault

Defence of a man with paranoid schizophrenia who attempted to stab a police officer whilst intoxicated and during an acute psychotic episode. Junior alone.

#### R v BH & 3 others [Blackfriars] 2018

Internet Banking Fraud

£500k internet banking fraud against elderly victims by bank employees. Catherine Farrelly led Charlotte Hole, instructed by the CPS International Justice and Organised Crime unit, prosecuting 4 defendants following an investigation by the National Crime Agency Cyber Crime Unit. The case centred around the activities of two men who worked at high street banks who assisted another in creating a significant number of sham bank account for the use in a transfer fraud, raising legal issues about the definition of 'criminal property' under s.340 POCA 2002.

#### R v. H [Kingston] 2018

Historic rape, buggery and sexual assault

Paul Jackson Led Charlotte Hole for the Defence of male charged with the historic rape, buggery and sexual assault of eight males over three decades. This trial involved an application to stay a count as an abuse of process, the analysis of volumes of third party material, section 41 applications, section 100 and 101 applications and submissions of no case. Instructed by TS Law.

# R v TK [Kingston] 2018

Operation Trident- Possession of live ammunition

Charlotte Hole defended a 21 year old social worker in an Operation Trident case, after live ammunition was found in her bedroom. The defendant faced a mandatory minimum sentence of 5 years, but was acquitted after trial.

### R v SB [Southwark] 2018

Assault on partner

Charlotte Hole defended an 84 year old man with Alzheimer's disease who was charged with assaulting his elderly partner, causing her significant facial injuries. The complainant was unable to attend Court, raising issues of hearsay, and the defendant was unfit to plead.

### R v Seabrook & ors [Woolwich] 2018

Conspiracy to supply drugs

Charlotte Hole, instructed by the CPS SE Complex Casework Unit, was led by Martin Yale, Senior Crown Advocate, in a 5 week prosecution of 5 defendants charged with conspiracy to supply drugs with a street value of over £10m, after 951kg of cannabis was found in a lorry load of rabbit hay. The case involved large volumes of telephone records, cell site evidence, and disputed evidence of co-location.

### R v SC [Westminster] 2017

Police officer assault on two teenagers

Charlotte Hole, instructed by the CPS Complex Casework Unit, prosecuted a serving police officer charged with assaulting two teenagers when called to a domestic dispute.

### R v AA [Central Criminal Court] 2017

Malicious communication to the police

Charlotte Hole defended a 25 year old with autism and learning difficulties, charged with malicious communications offences relating to threatening calls he made to the police. He was found unfit to plead, acquitted of one of the counts, and admitted to the National Autism Unit, a course the Probation Service had been unsuccessfully recommending for a number of years.

### R v. Akhtar [Southwark & C.O.A.] 2016, R v. Akhtar [2016] EWCA Crim 390 2016

Appeal against a decision to stay proceedings

Successfully defended a prosecution appeal against a decision to stay proceedings involving a vulnerable defendant where special measures were essential for a fair trial, but had not been put in place by the Court.
