Stephen has a background in criminal law where he prosecuted and defended in the most serious of cases as junior alone and as leading junior. He was appointed to the Attorney General's Panel of Prosecution Advocates for 6 years. Stephen lectures on such topics as public interest immunity for police officers, immigration officers and social workers and the interface between family law and criminal law to local authorities and police forces.

### Family Law:

Stephen is regularly instructed in complex care proceedings on behalf of parents and guardians, dealing with all forms of sexual abuse allegations, non accidental injury, serious neglect, forced marriages and indecent images. He also represents parents in contact and residence disputes, cases of child abduction, medical treatment (children and patients), cases of wardship/within the inherent jurisdiction and ancillary relief. Stephen was ranked in Chambers UK 2012 and 2013 for family law.

### Civil actions against the police and public authorities:

Stephen has extensive experience in civil actions against the police where he represents claimants and regularly appears in both jury and non jury actions. He regularly deals with cases of assault, unlawful arrest, false imprisonment, misfeasance in public office, malicious prosecution and breaches of European Convention rights.

Stephen has developed a successful practice in representing children and parents from Children Act care proceedings in Human Rights Acts damages claims against local authorities and health authorities. He has an expertise in dealing with cases involving the witness protection programme.

### Human Rights Law

Stephen has developed an expertise representing children, parents and grandparents from Children Act proceedings in Human Rights Act damages claims against local authorities and health authorities.

In addition Stephen represents a wide range of Claimants in civil actions against wider public authorities including families left bereaved by the wrongful release of psychiatric patients , farmers in a large scale fraud claims , actions against Local Authority planning departments and actions against the Home Office.

#### **Judicial Review:**

Stephen has made a number of appearances before the Administrative Court involving the refusal to allow early release of prisoners, miscalculation of prison terms, procedural unfairness in a doctor being struck off the medical register, government conspiracy to withhold information from serving prisoners, failures by magistrates to allow adjournments and interpretation of sentencing statute in respect of young offenders.

In the **Prison law** field, Stephen has dealt with numerous cases involving prisoners sustaining injuries by reason of attack by fellow prisoners, prison officers and by reason of unsafe work and other practices. Stephen has appeared in numerous contract disputes and has particular experience in dealing with civil cases involving allegations of fraud and is currently engaged in representing a large number of farmers in a large scale fraud claim. In **Employment law**, Stephen has experience in dealing with cases concerning disability discrimination, race and sexual discrimination and whistle-blowing cases.

## Recent Cases

### **K.C.C. v. S & C [Medway CC] 2017**

Baby Shaking Death of 5 month old son

Stephen Chippeck acted for the step-father in this 5 week Fact Finding involving the death of a 5 month old boy following a shaking incident. Instructed by Patrick Lawrence Solicitors.

### **Medway Council v. X 2016**

Care Proceedings

Stephen Chippeck leading Lizzie Wilson representing a learning and physically disabled mother who was alleged to have made up false rape allegations and child cruelty allegations against F. Following the hearing the allegations against her found to be false and her allegations against F found to be true and her child ordered to remain with her.

### **Medway Council v. B 2016**

Father accused of NAHI to baby

Stephen Chippeck representing learning disabled father with Paul Storey QC. F alleged to have caused serious head injury to baby. After the hearing F found not to be responsible for any injury.

### **Kent County Council v. Y 2016**

Father alleged to have caused NAHI to 9 day old baby

Stephen Chippeck representing young father alleged to have caused serious non- accidental injuries to his 9 day old baby.

### **Medway Council v A & Ors [2015] EWFC B66 2015**

"Shaken Baby Case"

Stephen Chippeck represented a learning disabled mother where allegations of shaking were found to be false and the baby was returned to her.

### **XYZ v. Chief Constable of Gwent Constabulary: [2014] EWHC 1448 (QB) 2014**

Misfeasance in a public office

Stephen Chippeck represented claimant in a claim of misfeasance in a public office brought by a police informer who was a Fathers4Justice campaigner arrested in possession of bullets and gunpowder.

### **London Borough of Barnet v M/F [2014] EWFC B152 2014**

Wardship / inherent jurisdiction proceedings

Stephen Chippeck representing a mother in wardship / inherent jurisdiction proceedings.

Stephen Chippeck acted for the appellant reversing Ryder J. A decision by the LSC not to fully fund the costs of a joint expert report ordered in private law proceedings under the Children Act 1989 , where the child had a public funding certificate but her parents did not was unlawful.

**Hussain v. Chief Constable of West Mercia Constabulary [2008] EWC Civ 1205, [2008] WLR (D) 342 2008**

Misfeasance in a public office

Stephen Chippeck represented the Claimant before the Master of the Rolls - what constitutes psychiatric or physical injury for the purposes of misfeasance in public office.
