He is frequently instructed in homicide cases at the Central Criminal Court and elsewhere, often involving gang murders.

His practise takes in all aspects of serious and organised crime, with an emphasis on fraud, money laundering and confiscation. He has particular expertise in cases involving RIPA, PII and disclosure issues. He has vast experience in prosecuting and defending cases of serious sexual misconduct.
